Chief's Report

- 1) Operations Update Chief Bentley reported that there were 9 Calls for service during April including 7 medical calls, 1 illegal burn and 1 public assist. The Chief mentioned that the Basin Wildland Drill was held at Pines Summit Camp with over 150 participants in attendance. The Chief stated that he would be meeting with the City of Prescott on Friday, May 8 to discuss the IGA for the transfer of Equipment 910 to the District and to review the current maintenance IGA with the City. He said that unless there was a stipulation to donate the engine to be replaced it would be sold in order to purchase equipment needed for the new engine.
- **2) Grant Update -** Chief Bentley stated that Tornado Damage Grant was almost complete and that grant would be closed out as soon as possible to receive reimbursement by year end,. The chief also mentioned that the AFG had began awarding and SAFER Grants have not began the award cycle.
- **3) Miscellaneous** Chief Bentley reported that he had made contact with an agency that can provide worker's compensation insurance at a potentially lower rate. He was hoping to have the information prior to the renewal for the current policy.
